Roy Brooksher, Jr. of Alex, Oklahoma was born in Lindsay, Oklahoma on January 6th, 1947 to Roy Brooksher, Sr. and Geneva (Palmer) Brooksher. He married Julie Ellithorp on June 4th, 1971 at Alex Southern Baptist Chapel in Alex, Oklahoma. Roy passed from this life on December 5th, 2010 at the Oklahoma Heart Hospital in Oklahoma City, Oklahoma at the age of 63.
